BEFORE ARRIVAL

VISA

The full workflow and the communication with the Italian embassy takes place through University portal (<https://www.university.it/>). The ECRS course has no role in this process and there is nothing the course can do to speed it up. Procedures, timing, and costs depend on the Country of origin.

You will probably (it may vary with the country) be asked to provide the following documents:

Documents and forms :

- Entry visa application form ([View](#))
- recent passport-size photograph
- valid travel document whose expiry date is three months longer than that of the visa requested
- proof that the applicant has adequate accommodation in Italy
- proof that the applicant has sufficient means of subsistence of no less than € 460.28 for each month of the academic year. This can be proven in one of the following ways: evidence of personal or financial resources; economic guarantees provided by Italian institutions and bodies of an established credit, by local Governments, or by foreign institutions and bodies considered to be reliable by the Italian diplomatic mission
- enrolment or pre-enrolment in the course to be followed in Italy
- the requirements and procedures for the issue of visas are indicated in a special provision, published annually by the MIUR, in agreement with MAECI and Ministry of the Interior

Furthermore, in some countries getting an appointment with the Italian embassy takes several months. Non-UE Future students, who may have visa problems, are welcome **to ask by mail (cds_ambiente@uniss.it) for an entry on-line interview as early as possible**. Applications for Visa (University Enrolment for 25/26) have to be advanced by November 30 2025, but consider that classes start at the beginning of October 2025.

Requirements for enrolling

Admission to the Master Degree in ECRS is subject to possession of a three-year bachelor degree or a three-year university diploma, or another qualification obtained abroad (recognized) at the condition you have acquired at least 42 ECTS in scientific disciplines to be evaluated by a ECRS board. All the exams taken during the bachelor degree should be listed. A knowledge of the English language at level B1 is also required, proven by a university course, a certification or verified through an interview. For enrolment all the material to provide for admission should be translated in English and certified by CIMEA (<https://www.cimea.it/EN/pagina-procedure-riconoscimento-titoli>), if it was not released in English.

So, to explore your eligibility for enrolment please send to cds_ambiente@uniss.it your carrier documentation (a curriculum vitae with the list of the exams taken can be enough).

With intention of enrolling, you should send the material in English or translated in English to Rita Cubeddu rcubeddu@uniss.it.

Enrolment at UNISS

You can enrol only after your admission requirements have been checked and you have been interviewed. Registration at (<https://uniss.esse3.cineca.it/Home.do>) will provide you with a UserID and Password to access the student reserved area, where you can complete the enrollment procedure and register for subsequent academic years after the first.

Tuition fees at UNISS

In few days we will be noticed about exact fees for the 2025/26 which will depend on the on the country of origin, merit and income. Please stay tuned!!

The costs to attend a master's degree course in Sassari consist of three items: tuition fee, virtual stamp, and regional tax. Payments are scheduled in three tranches expiring respectively in October (part of the tuition fee + virtual stamp), February (part of tuition fee + regional tax) and April (possible last part of the tuition fee).

Scholarship

The ECRS course does not assign scholarships.

At UNISS student scholarships are assigned by a regional agency named ERSU. A yearly call is published by ERSU in July. The call for the academic year 2025/2026 has just come out (<https://ersusassari.it/it/novita/notizia/Pubblicazione-Bando-di-concorso-Borse-di-Studio-e-Servizi-Abitativi-a.a.-2025-2026/>) with deadline September 8, 2025. The participation requires some bureaucratic duties that need your presence in Italy (e.g. ISEE) as scholarships are based mostly on family income, which can be hard to certify for International students. So, in fact, they are only useful for the second year of the Master.

Accommodation

STUDENT HOUSE

Rooms might be available in ERSU student houses located in Sassari.

A room in a student house can be obtained only once enrolled.

Prices (per person per month) range from 170€ in a double room to 225€ in a single room.

PRIVATE APARTMENTS

Renting a room/apartment from private owners represents an option. However, its search and contract definition is only possible on site. Prices (per person per month) are on average 230-250€ for single rooms in a shared apartment and 150-180€ for shared rooms. Private apartments or studios can be found but the cost for a decent location and apartment conditions is never below 400€/month. These amounts usually do not include bills (e.g. electricity, gas, water, wi-fi, waste recycling; roughly additional 50€/month) nor deposit. Some owners ask for a person already in Italy who can guarantee for you.

Rent contracts usually have a minimum duration of 10-12 months. The best period to locate rooms/apartments is from June to September; during the rest of the year it might be difficult to find apartments/rooms.

For early accommodation upon arrival (until finding a final accommodation), the city offers several affordable rooms in B&B (<https://www.airbnb.it/>), *affittacamere*, apartments, and hotels (<https://www.booking.com/index.it.html>).

Health Insurance and access to the Italian National Health care system

It is usually requested by the Italian Embassies and Consulate to have an insurance policy prior to arrival. However, also on arrival it would be safe to be covered by a travel health insurance policy taken out in your home country. Once here, as a student, it will be possible to be covered by the regional health system through the payment of 150,00 euros per solar year. This possibility is only given to students after the residence permit procedure is completed (see below "permesso di soggiorno").

However, we remind you that emergency hospitalization without charge in Italy is guaranteed for health issues caused by accidents or any sudden health problem, also to foreign citizens and students.

Italian Language

Although the official language of the course is English, living in Sassari you may experience difficulties communicating for your needs (bureaucracy, accommodation, shopping, etc.). This is why you might consider learning at least some basics of the Italian language already before your arrival (for instance while waiting for your visa).

UNISS offers the possibility of having a course of Italian language on-line (<https://www.uniss.it/it/ateneo/strutture/centro-linguistico-di-ateneo-cla/corsi-di-lingua-italiana-stranieri/1st-semester-4>).

AFTER ARRIVAL

Permesso di soggiorno (Residence Permit)

This is the most exhausting task. For the Italian regulation, any non-EU student can stay in Italy only with a residence permit (permesso di soggiorno). The application for this document can be submitted at a post office within 8 days from your arrival, that will give you a complicated application form and an appointment for the next steps. The subsequent steps must be carried out in person at the Immigration Office located inside the Local Police Station (in Italian: Questura) which is in charge of issuing the permit. Both at the Post Office and at the Questura you might face an officer who does not speak English; so if you don't speak Italian, it is a good idea to be accompanied by an Italian speaker. Especially with Questura the interaction can be tough.

Overall costs for the release amount to approximately 70 € plus 30 € to get the first application form and deliver it at the Post Office. The residence permit is valid only for 1 year. Before the end of that year you have to submit a renewal request and go through the same initial procedure and costs. Only with a valid Permesso di soggiorno you can apply to receive health care (see above Health Insurance and access to the Italian National Health care system), and you need health care/insurance to get the renewal. The residence permit will be issued after several months from the application. You will be notified and should go and take it at the Questura.

Phone and wi-fi

It is easy to buy a sim card and change the operator. Some apartments are rented with wifi (extra costs). In the university facilities, wifi is available for free to any student enrolled (two available nets: *unissmobile* and *eduroam*, both accessible using the student's credentials).

Transport within and outside Sardinia

Sassari is located on the island of Sardinia. The city has a bus service (ATP lines and timetable). The shuttle bus to the local airport (Alghero Fertilia 30km away) runs approximately once every 2 hrs (<https://app.arstspa.it/quadri/760.html>). The other airports in Olbia (110km) and Cagliari (220km) are not so well connected. Regional connections are possible by bus or by train, but rides are not very frequent.

Connections with other destinations in the country or abroad are possible by plane or ferry boat (through Porto Torres and Olbia ports). The closest airport in Alghero is connected with main Italian airports and with several foreign destinations depending on the season. You can book flights at affordable prices (especially if not in summer) from low cost companies. Tickets for both flights and ferries can be easily bought online.

Canteen

The regional agency ERSU manages a canteen in Sassari where it is possible to find menus based on traditional regional recipes and which take into account the needs of students with food intolerances, vegetarians and vegans (<https://www.uniss.it/en/international/incoming-mobility/guide-services-incoming-mobility-students/university-canteen>).

To benefit from this service, you must be registered to ERSU. Once registered, if you receive an ERSU scholarship, you will automatically have access to the canteen; if you have no scholarship, you can pay for single meals, the cost depending on your income (ISEE). Meals are usually cheaper than local restaurants, diners and bars.

FAQs

- 1. I am an international student and I have completed my registration on the University portal. Can you send me a formal acceptance letter from the University of Sassari?**

The visa application is automatically sent to the Italian embassy from the University portal, we don't issue acceptance letters.

- 2. I am an international student. How can I apply for a scholarship offered by the University of Sassari?**

There are no specific scholarships for international students. A call for regional scholarships is published at the end July (deadline in mid September) by ERSU (the Regional Authority for the Right to University Studies), but you have to be in Sassari to be able to apply (you can consult their website).

- 3. Do you have available accommodation for students?**

Rooms might be available in ERSU student houses located in Sassari, or you can rent a room/apartment from private owners.

- 4. How can I get updated on the status of the submission of my pre-enrolment documents to the embassy through the University portal?**

For everything related to University you need to contact our university secretariat (Dr.ssa Rita Cubeddu - rcubeddu@uniss.it).

- 5. When will enrolment be open?**

Enrolment opens on 1 August 2023 and expires on 16 October 2023. Only students who have interviewed are eligible for enrolment. They will be notified by email as soon as they are allowed to enrol.

- 6. What happens if I have not yet obtained my visa by the enrolment deadline?**

You will get an extension until 15 January 2026.

- 7. When will the classes start?**

Classes will start the 1st of October.

- 8. What can I do if I have completed my enrolment procedure but I do not have the visa before classes start?**

If you have been admitted to the master course, you will be admitted attending the classes. If you are an international student and you have not yet obtained your visa, you will be given the opportunity to attend the lessons online. But unfortunately, practices are only in person.

9. Could you please provide me with the tax code?

UNISS does not release the tax code (codice fiscale).

You can request it to the Italian embassy or consulate in your country (before your arrival), or at a Tax Office (Agenzia delle entrate) in Italy (once arrived).
